Dunkettle Interchange Project - Advance Works

Upgrade Dunkettle to a largely free-flow interchange to alleviate traffic congestion.

- Works on diversion of the 900mm diameter watermain have reached substantial completion and the diverted watermain has now been brought into service by Cork County Council/Irish Water.
- Piling works in the area between the Pfizer premises and the N25 westbound are scheduled to get underway on Monday 5th October 2020 - details to follow in future updates.
- The new traffic lights at the Dunkettle Roundabout have been activated. Road Safety Audit is currently being completed at this location. The new footway/cycleway commencing from this location

will be opened to traffic following on from completion of the safety audit process.

- The section of footway/cycleway to be opened is shown on the graphic below – Point A to Point B and Point C to Point D. The graphic also illustrates how this section will tie in with Cork City Council’s plans for cycleways in the Glanmire area – Point B to Point E (currently at design stage), and with Cork County Council’s plans for cycleways along the old N25 eastward from Glanmire – Point D to Point G (construction soon to commence) . Further to this, a section of cycleway, Point D to Point H is to be constructed as part of the Dunkettle Project which will complete the cycleway link from Tivoli to Little Island.

Installation of gantry mounted Variable Message Signs and other infrastructure to display traffic information such as journey times.

- Works are continuing on the three locations between the Jack Lynch Tunnel and the Bloomfield Interchange. See photograph below showing ongoing works on the site adjoining the N40 westbound traffic lanes, immediately south of the Jack Lynch Tunnel.

- Hard shoulder closures will remain in place at these three locations for several weeks but no significant disruption to traffic is anticipated as a result.
